Oh No! Mosquitoes

TURF REDUCTION EXPLAINED

As our water condition worsens, Nevada's allotment from the Colorado River will decrease. Grass requires 4x more (55 gallons more per sq. ft.) water than drip irrigation landscaping. For this reason, Nevada Assembly Bill 356 requires removal of nonfunctional turf.

What is nonfunctional turf vs. functional turf? It is not necessarily what you think. Functional Turf must be:

- a minimum of 1,500 contiguous sq. ft.
- co-located with facilities such as trash bins, benches, tables, walking paths
- a minimum of 10 feet from the street unless at least 30 feet in all dimensions
- installed on slopes less than 25 percent

All of our community's turf was initially deemed nonfunctional, requiring removal. The Board obtained waivers from SNWA for the Soft Winds Roundabout Park and for the north and south sections of Lady Lake Park, so we will keep the grass in those areas. We will be removing all of the grass along Mariner and Harbor Island and at the entrances to neighborhoods.

The Board has just approved LandCare to head up our turf reduction project. As a team, we are all working hard to meet the requirements of Bill 356, while maintaining the beauty of our community and keeping the cost down.

To do this we must weigh the pros/cons, cost, and long-term maintenance of artificial turf vs., desert landscaping, watering systems, and plant choices. While one may look nicer than another, we have to consider if the increased cost to the Homeowner outweighs the long-term benefit. We will receive a rebate for the conversion, but it does not nearly cover the cost of the project. As this is an unexpected expense, homeowners will need to pay a Special Reserve Assessment.

Each month, we have a special turf reduction meeting. We encourage you to attend and join the conversation. The next one is Oct. 11th at 3:00. We hope to see you on zoom.

TREASURER'S REPORT FROM JOYCE LUSH

While our community is in very good financial shape for day-to-day operations, we are NOT in good shape for the unexpected and unplanned costs of complying with Bill 356 and removing turf along roads and at neighborhood entrances. This means that we all will need to pay an additional amount, a "special reserve assessment," to cover these costs.

The Board is working through both the amount per household and the timing. The cost will be distributed across houses, condos, and commercial properties in the same proportion as the regular assessment. We tentatively plan a 6-month time period for paying this one-time additional assessment.
